988 Suicide and Crisis Lifeline Launches



In July ND launched its counterpart of the 988 suicide and crisis lifeline that rolled out across the country as part of the National Suicide Hotline Designation Act. This legislation created an easy-to-remember telephone number that would increase accessibility of the Lifeline.

When a North Dakota resident calls the National Suicide Lifeline, a trained member of the state's Lifeline crisis center, FirstLink, answers. FirstLink staff listen to the caller, understand how their problem is affecting them, provide support, and share resources if needed. If additional support is needed, FirstLink connects the person to their local Human Service Center's mobile crisis team.

Education Advocacy Consortium: Advice for Families Struggling with School Attendance



Education Advocacy Consortium partners, including NDFFCMH and ND Protection & Advocacy Project have been monitoring the implementation of CHINS and growing issues surrounding school attendance for children with disabilities or suspected disabilities.

ND Century Code requires school attendance for children until they reach 16 years old and penalizes failure of students to attend school. However, there are some exceptions. Century code establishes that "in a prosecution for an offense under this section, it is an affirmative defense if the person responsible for ensuring that the student is in attendance has made substantial and reasonable efforts to comply with the requirements of this section, but is unable to compel the student to attend school. If the court determines that the affirmative defense is valid, the court shall dismiss the complaint against the person."

Parents and school teams are encouraged to collaborate to get children to school in as integrated a setting as possible, but there are going to be occasions in which some students, due to their disability are struggling to get to school. While the above section of Century Code should be protection for guardians under those circumstances, our system partners have offered some useful advice in case more is needed.

If a child is under an IEP, it may be advisable to write into the IEP that a student does not need to follow ordinary school attendance policies.

Interim Acute Psychiatric Treatment Committee



The Acute Psychiatric Treatment Committee met in October at Prairie St. John's Hospital in Fargo. Bill drafts relating to the State Hospital were presented. Disability advocates would argue that the issue of the IMD Exclusion Waiver loomed large over the hearing. The IMD Exclusion was created to ensure that states would not have an overreliance on institutional care for people with psychiatric disabilities instead of community-based services in or near their home communities. To do this, the federal government severely restricted the opportunities states and institutional facilities could use Medicaid funding for institutional placements of people with psychiatric disabilities, limiting such reimbursements for facilities that have 16 beds or less.

Despite these restrictions, there are options for states to pursue to remove those barriers. States can apply for an IMD Exclusion Waiver (also known as a Section 1115 waiver) to allow for facilities larger than 16 beds to reimburse their services through Medicaid. There is significant interest from providers like Prairie St. Johns and Sharehouse to do this. The concern is that doing this may irreparably
